Notice is hereby given that the Board of Directors of the Willacy County Drainage District No. 2 will meet on MONDAY, FEBRUARY 1, 2021 AT 2:00 P.M.

- 1. Comment may be made by emailing the District at info@willacycdd2.org before 2:00 p.m. on February 1, 2021. The email will be read during the public comment period.
- 2. All individuals desiring to address the Board by must be registered to do so by calling the District at (956) 347-5164 between 8:00 a.m. and 1:30 p.m. on February 1, 2021, and register by providing his or her name. The registered speaker will access the meeting as stated above. When is time for comments to be heard, a moderator will move through the list of registered speakers, stating the name of each, at which time the speaker will make his or her comments.

The open public forum/comment period shall not exceed one-half (1/2) hour in length and each speaker will be allowed a maximum of three (3) minutes to speak. The purpose of this comment period is to provide the public an opportunity to address issues or topics that are under the jurisdiction of the District. For issues or topics which are not otherwise part of the posted agenda for the meeting, Board members

may direct staff to investigate the issue or topic further. No action or discussion shall be taken on issues or topics which are not part of the posted agenda for the meeting. Members of the public may be recognized on posted agenda items deemed appropriate by the Board President as these items are considered, and the same time limitations (3 minutes) apply.
